## **Development Proposal**



Carrickshock GAA Club are undertaking a new development plan to develop a new all weather training facility and walking track on the club's existing land in Hugginstown. An extension and refurbishment works to the existing Sports and Community Hall will also be undertaken to include the construction of a new gym, sports studios, meeting rooms, dressing rooms and toilet facilities.

## Timeline



Mid 2023 will see the commencement of works on the new Carrickshock GAA Development in Hugginstown. This project will be split into 2 phases.

### Phase 1:

Construction and installation of a new large all weather playing surface, surrounding ball wall, walking track and associated fencing. It is hoped that Phase 1 will be completed before the year end.






# Timeline

### Phase 2:

Mid 2024 will see the commencement of Phase 2 of the development which will include an extension of the Community Hall, new Gym, meeting rooms and sports studios. Refurbishment works and redecoration of the existing dressing rooms will also be undertaken.



# **Project Costings**



The project has been fully costed and is estimated that on completion, the project will cost  $\in$  870,000 over the 3 years.

# Funding



Funding the project will consist of many elements from varying sources outlined below.

- 1. Community Contribution Scheme
- 2. Corporate Contribution Scheme
- 3. Club Fundraising Events



## Funding



### **Community Contribution Scheme:**

The Club is aiming to secure 200 members of the community to commit to financial contributions under 3 payment options:

- 1. A once off payment of **€900**
- 2. 3 Annual payments of **€300** for 3 years.
- 3. Monthly payments of **€25** for 3 years.

In return for your generous commitment and to show our sincere appreciation, we will erect an acknowledgement plate on the fencing around the walking track for each contribution, similar to that shown in the image below.

The club have already received a Sports Club Tax exemption and will be able to receive a tax refund on your generous contribution, effectively increasing your contribution by potentially another  $\in$  360.





## Funding



### Corporate Contribution Scheme:

The Club is asking the local business community to help us in our plans to build a community facility and centre that will improve the health and well being of it's people and create a space that is open and available to all.

We are asking for a once-off generous and tax deductible **€5,000** sponsorship & advertisement package from businesses. This will get your business a large advertisement space along our entrance wall for the next **five years**. Each space is approximately 3m x 2.5m with your own business advertised on a 1.5m x 0.5m advertising board similar to the image below. In addition and to show our sincere appreciation for your sponsorship, the club are erecting a large permanent commemorative 'Friends of Carrickshock' plaque on the wall of the Community Centre thanking those who have helped us realise our, and the local communities, dream.

- 8. The amount of my aggregate annual donations to an approved body (or bodies) with which I am associated (see Notes) will be restricted to an amount equal to 10% of my total income for the tax year in question and tax relief will not apply to any donations in excess of that amount.
- 9. I must pay income tax and/or capital gains tax for any tax year in which I make donations of an amount equal to the income tax on the grossed up amount of the donations in order for the approved body to receive a refund of tax (see Notes).
